ARTHUR AND NELLE HODSON

Arthur x'34 and Nelle (Leisman '43) Hodson have long-time connections to the Upland community. Both were born in Upland, have worked in and significantly contributed to the community.

Nelle was born in 1922 and lived most of her childhood in Michigan. She majored in home economics and English at Taylor and taught home economics at Eastbrook Community Schools and later at Taylor University, investing time and energy into young lives, modeling social grace and poise.

Nelle and husband James Alspaugh '39 gave birth to a son, Michael '78. Her grandsons, Shawn '02 and Matthew '04, complete a fourth generation of Taylor alumni.

Art was also born in Upland in 1912 and worked at the Upland Bank (now Star Financial) where he held a variety of positions, including president and chairman of the board until retirement in 1977. In addition, he served on the Taylor Board of Trustees from 1959-1963. Art has also worked as a farmer and served as a Christian leader in the community for many years.

After James' death in 1983, the common bonds of the University, family values and faith led the couple to marriage on Sept. 21, 1996. Together, Art and Nelle have demonstrated a model of stewardship and commitment to Christ and Christian higher education. Out of their love for education and the Upland and Taylor communities, Art and Nelle have contributed significantly to Taylor through planned giving vehicles such as scholarships, annuities and unitrusts. They also have made possible the Alspaugh East and West banquet facilities and now the atrium addition to the Hodson Dining Commons.

It is with sincere gratitude and appreciation that we honor Art and Nelle Hodson for their abiding commitment to Taylor University and for their love and devotion to God, family and community.
