## Music Education Curriculum Gets State Approval for Fall Opening

Final approval of the music education program, which is now included in the college's curriculum this fall, was granted the college by the Teacher Training and Licensing Commission of the State of Indiana at one of its meetings in Indianapolis in July. Previous accreditation for the two-year elementary teacher training program had been given in May, but action on the music courses was postponed at that time inasmuch as the key examiner who had evaluated the curriculum on the Fort Wayne Bible College campus was not present at the May session.

The music program, now in effect, is designed to prepare students for teaching music in elementary and secondary public schools. The courses lead to the degrees of Bachelor of Science in Music Education, a four-year program, and Bachelor of Music Education, a five-year program. While these courses

and Bachelor of Music Education, a uphold the spiritual objectives of the college, each one containing 30 hours of Bible and Theology, they also fulfill the requirements of many states for directors of choral and instrumental music in public schools. The music supervisor of the Fort Wayne public schools has approved practice teaching in the city schools for students in these courses.

New courses included in these programs include School Music I and II, Music Practice Teaching, orchestration, canon and fugue, and basic techniques in stringed, woodwind, brass and percussion.

The program is under the direction of Lansing Bulgin, director of the School of Music and the music

#### Fall Registration Totals 332 Students

The fall term of the college opened on Monday, September 12, when new students began a four-day orientation program. During the week 130 new students enrolled and the total registration was 332. This includes 17 girls which are enrolled at the Lutheran Hospital as part of a cooperative program between the hospital and the college in nurses' training.

Opening activities included freshmen examinations and informal programs. A big brother-big sister party was conducted by the student council, and the week ended with a faculty-student get-acquainted dinner.

#### Ralph A. Gallagher Named To Faculty

Rev. Ralph A. Gallagher, formerly of Whitehouse, Ohio, was named to the faculty in August to begin teaching duties with the college this fall. He will teach history and science.

Mr. Gallagher attended Cleveland Bible College and later graduated from Huntington College. He also received the Bachelor of Theology degree from Huntington. He has the Master of Arts degree in history and science from Bowling Green State University, Bowling Green, Ohio. He is an ordained minister of the

He is an ordained minister of the Evangelical United Brethern Church and pastored the E.U.B. church in Whitehouse before coming to Fort Wayne. He moved to the city with his wife and three children in August.

#### **Building Project Report**

As the college continues to develop, the need for a library and an office-classroom building becomes more acute. These buildings will be the first to be erected on the south campus and will provide for educational functions, leaving the present campus largely for living quarters.

A substantial beginning has been made toward raising the needed funds. \$225,000 is needed for the library, and \$500,000 for the administration-classroom building. At the end of the fiscal year, June 30, the total received in cash and pledges for the whole undertaking was \$130,971.46. Some additional gifts have come in since then.

The Building Committee is seeking a God-chosen man who can give his full time to presenting this need. It desires the prayers and the whole-hearted support of all friends of the college in this important undertaking.

#### School of Music Appeals For Used Instruments For Use In Music Education Courses

With the addition of the music education courses in the School of Music, more musical instruments are needed immediately. Friends having band or orchestral instruments who no longer use them may donate them to the college where they are greatly needed. Particularly needed are trumpets, trombones, clarinets and a flute. #### Bible College Education For Today

This is no time to soft-pedal Bible education. The day in which we live calls for a strong, virile type of Christianity, which can be nurtured only by sound Bible instruction. A weak, spineless, namby-pamby form of esthetic religion with Christian names and sentiments attached to it is no more than a soothing nostrum. The only antidote for humanism and pragmatism is the living authority of the Word of God for both substitute reason for revelation and both repudiate the moral authority of a sovereign God. Further, the only way to offset the demoralizing, despiritualizing impact of modern society is to be thoroughly saturated with the Word of God.

And what about an orthodox Christian college in which 95 per cent of the subject-matter is secular, much of which is not integrated with Christian faith? And what about a giddy whirl of world-mimicking activities that drain spiritual life and which call for a periodic revival in order to restore the element of seriousness in the Christian life?

Bible education is a necessity at the college level if for no other reason than during the college period basic convictions are formed. Most students need to be "grounded and rooted" in the Christian faith. Adequate education must be more than a smattering of Bible or even a given number of hours of credit. It must be education in terms of conformity to the will of God and the image of Christ.

Significantly, the educational world today appears to be less prejudiced and more open-minded toward Bible-oriented education than much of the religious world. Our college has generally been accorded respect by secular educational agencies and its credits have sometimes been more readily recognized by secular institutions than by religious. It has been gratifying to observe courtesy, reasonableness, and open-mindedness among secular educators, but it has been disheartening to observe the prevalence of prejudice and disparaging attitudes among the Pharisees of higher education.

William Lyon Phelps was right when he said that a Bible education without college is worth more than a college education without Bible. But it does not need to be one without the other. The Bible colleges that have come to the kingdom for such a time as this offer a unique combination of both.

#### Youth Conference Set For October 28-30

The 16th annual Youth Conference of the college will be held on the college campus October 28-30, with Jim Rayburn, National Director of the Young Life Campaign, as principle speaker.

Jim Leever, senior student of Detroit, Michigan, is chairman of this year's conference. The theme will be "Truth for Youth." Complete announcements concerning the conference will be given in the October issue of VISION.

#### Alumni Board of Directors Convenes; Expansion of Alumni Activity Planned

A three-point program of alumni planning for the current year was adopted by the alumni Board of Directors during the summer at a meeting which was held at the Hobby Ranch House in Fort Wayne on June 20. Immediate goals for the expansion of the Alumni Association and the functions of the new alumni office were outlined. Those who attended the meeting were J. Harlan Wright, president of the association; Vernon J. Peterson, vice-president; Arnold Schmidt, treasurer; Helen Schumacher, Board member; Harvey Mitchell, faculty representative; Richard Gerig, alumni co-ordinator, and Dr. S. A. Witmer, president of the college.

The three goals set forth for this year are: (1) inauguration of a bimonthly news letter for all alumni and former students; (2) preparation of a chartering procedure for alumni chapters together with suggested chapter constitutions; (3) adoption of a long-range program for increasing the regular financial support of the college by its alumni and former students through the association. These goals are aimed to provide more thorough news coverage of alumni, to organize and standardize alumni activity in various areas, and to strengthen and correlate means for better serving the college.

The Board also agreed that the functions of the new alumni office on campus be to maintain alumni files and records, to act as liason between the college and the association, to prepare alumni bulletins and handle alumni mailings, to be the center for alumni news and communications, and to carry out the directives of the alumni Board. Richard Gerig, Director of Broadcasting and Promotion for the college, was appointed by the college administration in June to serve as the alumni co-ordinator. Donna Harvey, class of 1955, is secretary in this office.

The Board also adopted the resolution that it "heartily endorse the spiritual and academic program now being carried on by the college."

Please pray for the alumni Board, officers, and staff, that the alumni activity might be effective in helping the college achieve its ministry.
