Christian Librarians' Fellowship Conference

The annual conference of the Christian Librarians' Fellowship (CLF) will be held on campus, June 9-11. The CLF has member librarians from Bible Colleges and Christian liberal arts colleges from across the United States and Canada. They meet for fellowship and discussion about library service.

Chairman of the conference is Miss Hilda Kroeker of Calvary Bible College, Kansas City, Missouri. Program chairman is Dr. Ruby E. Dara of Greenville College, Greenville, Illinois.

The featured speaker is Dr. John Montgomery of Trinity Evangelical Divinity School, Deerfield, Illinois. Dr. Forest Weddle of Fort Wayne Bible College will discuss "Motivation in College Reading". Dr. Jared F. Gerig will bring the official welcome. Host librarians are Miss Edith Ehlike and Mr. Richard Elmer.

This is the 10th anniversary of the CLF. It is continually seeking to advance the standards of library service in Christian schools. It seeks also to promote spiritual, professional and scholarly growth of those who work in the libraries of these schools. The CLF published the **Christian Periodical Index** and the quarterly newsletter, **The Christian Librarian**.

Mr. Warner will be on sabbatical leave of absence this coming school year studying toward his doctorate at Indiana University.

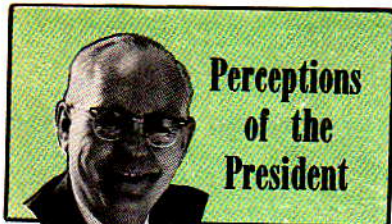
Dr. Kenneth Kantzer Is Commencement Speaker

Conditions of Conquest

Someone has said very aptly, "The conditions of conquest are always easy. We have but to toil awhile, endure awhile, believe always, and never turn back." If we apply these conditions to the spiritual, we discover that they are the conditions of success in the life of the individual Christian, as well as in the life of the church. It was something on this order that the aged Paul wrote to the young Timothy. "Preach the word; be instant in season, out of season; reprove, rebuke, exhort with all longsuffering and doctrine. . . . But watch thou in all things, endure afflictions, do the work of an evangelist, make full proof of thy ministry." (II Tim. 4:2,5)

We are facing another graduation at Fort Wayne Bible College and to another senior class it is fitting to say, "There is a job given you to do: Be instant! Toil and work! Learn to endure patiently! Never doubt your calling! Never give up the job! Make full proof of your ministry!"

THE LACKING CONDITIONS

Every servant of the Lord could well consider these conditions of conquest. Let every man do his work. Let him do it: watching, enduring, expending, believing, proving. Any failures in the high and holy work of the Lord will be caused by not complying with one or more of these basic conditions. The times demand that those who are called know these conditions and meet them unflinchingly to the fullest degree.

THE LACKING CHALLENGE

In the larger sense, there has been much to regret in the ministry of the church where she has resigned from the main job of preaching the Word and has taken the easier course of lesser important endeavors. There was not so much to endure, less to rebuke, and the "instant in season" was diluted to "instant on occasion." Much of modern lukewarmness originated with the loss of challenge to conquest, and an attempt to ease up on the conditions for glorious spiritual success. We need to get back to rugged training, cutting sacrifice, and dogged faithfulness in the important work of the Lord.

THE LACKING MANPOWER

Is the lack of men in the glorious ministries of the Church due to a lack of challenge, a diluting of the demands, a reducing of the rigors? Are we asking for too little? Certainly this is not the way nor the spirit of the Cross. When Jesus exhorted, "Come, take up your cross and follow me" He was literally saying, "Come, share my sacrifices, endure my sufferings, die my death." He wanted men, real men, who would work, sweat, fight, suffer, bleed, and die in this spiritual warfare. The conditions of conquest are the same, Do we have men to meet them?

Christian Association of Deans of Women To Meet

The Christian Association of Deans of Women (CADW) will meet for their summer conference June 8-11 at Fort Wayne Bible College. The theme of the conference is "Conflicting Ideas in a Changing World." Miss Donna Lutton, dean of women at Fort Wayne Bible College will be the hostess.

Miss Ida Adolphson of John Brown University is president of CADW. She will be speaking about role playing. Dr. Edward Simpson, dean of the Fort Wayne Bible College will be the main speaker. Mrs. Jean R. Kline, associate dean of students at Wheaton College and vice president of CADW, speaks on the topic, "What's Your Problem." Miss Sara Petty, dean of women at Columbia Bible College, speaks about "The Plus of Deaning."

First National Men's Congress

A men's congress is planned for the week-end of August 26-28 on the Fort Wayne Bible College campus. The first such venture planned, the congress is designed to bring together men of the Missionary Church Association and the Evangelical Mennonite Church for fellowship and inspiration.

Speakers for the event include U.S. Congressman J. Edward Roush; the Rev. Don Price, a former Indianapolis outlaw, now director of the rescue mission in Saginaw, Michigan; Dr. Myron Augsburger, president of Eastern Mennonite College; and the Rev. Gerald Gerig of Berne, Indiana.

More details will be announced later, but men are urged to keep the week-end free for this First National Men's Congress.

College Student Loan Plan

A new loan plan for college students is now available to Indiana residents. It is described in detail on pages 4 and 5. Similar plans are available to Fort Wayne Bible College students coming from many other states. In addition, National Defense Student Loan funds have doubled and the Bible College is seeking additional grants-in-aid for those qualified. Dean Elected To Top Post

Dr. Edward Simpson, dean of Fort Wayne Bible College, has been elected chairman of the advisory committee of the World Evangelical Fellowship's Christian Education Department at the first official meeting held recently in Milwaukee, Wisconsin.

The advisory committee directs the program for the newly organized Christian Education Department of World Evangelical Fellowship. The major emphasis of the department's work is helping missionaries and nationals on the field with their Christian education ministries.

Veterans Educational Assistance Available

On March 3, 1966 the President of the United States signed into law a new act giving educational assistance to veterans. Those who have served in the armed services since January 31, 1955 may be eligible.

Benefits for full-time students range from \$100 for single veterans to \$150 for those with two or more dependents. Questions about eligibility should be addressed to the nearest Veterans Administration Regional Office. A pamphlet describing the program and application forms are available from the Business Office of the Bible College upon request.

Housing for married students is readily available. Questions regarding such arrangements should also be addressed to the Business Office.

COLLEGE STUDENT LOAN

The College Student Loan Plan was created for the purpose of improving higher educational opportunities for residents of Indiana by providing loans with a low rate of interest and liberal repayment terms. Loans will be made through banks and other local lending institutions.

This plan, by guaranteeing repayment of long term loans, will assist students in obtaining loans to cover part of their college expenses.

In February, 1966 Governor Roger D. Branigin, understanding the need of many students of the state to have easy access to low cost loans for college, asked the State Scholarship Commission to establish and administer a guaranteed loan program. This program will bring together the interest subsidy and other benefits made available by the federal government, the guarantee of repayment of the State of Indiana and the lending power of banks in each community. It is hoped that these cooperative efforts of the banks, the state and the federal government will assure funds for all qualified students.

How Does the Plan Work?

1. The student obtains the application form from the bank (or other lending institution) in his home community or from his college or university.
2. The student and his parents complete the portions of the application applicable to their case. Parents must sign the application but do not assume liability for the loan.
3. Student presents application to the financial aid officer of the college in which he has been accepted or is enrolled. (A business-size envelope addressed to the bank should be included.) The college financial aid officer will certify enrollment status and other information and forward the application to the bank.

4. The bank will informally verify the financial picture of the student and certify the amount it is willing to loan and forward to the College Student Loan Plan office.

5. The College Loan Plan will review the application, approve or disapprove the guarantee where appropriate and return the application to the bank.

How Much Will It Cost?

While the student-borrower is in college, he will pay only 1/2 of 1% guaranteed interest on the loan. The 6% interest, which is the rate when the loan is made, will be paid by the federal government. When the college instruction ends, the federal guarantee ends and charges will be 3% until the payment begins.

What About Repayment?

Nine months after a student begins his education, the repayment begins. At this time the federal guarantee continues to pay 3% and the student pays 3% in interest. Repayments are made to the bank at which the loan was negotiated.

How Much May a Student Borrow?

The maximum a student may borrow under the plan is one thousand dollars. Undergraduate students while enrolled in an undergraduate program may borrow up to fifteen hundred dollars maximum per year. A bank may elect to limit the size of a loan to an amount smaller than the maximum.

Who Is Eligible?

In order to be eligible a student must:

1. Be accepted by or enrolled in an institution of higher education in the United States.
2. Be a full-time undergraduate student in any year of college.

formally verify the financial status of the student and family, and determine if it is willing to lend under the College Student Loan Plan.

The Loan Plan will consider the recommendation of the lender to approve or disapprove, authorize or refuse where appropriate and submit the application to the bank.

Will It Cost?

If the borrower is in school he will be required to pay a guarantee fee to insure the loan, which starts as soon as the loan is made and will be paid entirely by the borrower. When the period of the loan expires the federal share of interest will be paid until the principal is repaid.

Repayment?

When a student graduates or terminates his education, the repayment period begins. The federal government will pay the interest and the student will pay the principal. Payments will be made to the lender. The loan was originally

How Much Can a Student Borrow?

A student may borrow under this plan up to \$1,000 a year for undergraduate students and \$1,500 for professional students. A bank may, however, limit the amount of a loan to an amount determined by the bank.

Who?

A student must be enrolled in an eligible program of higher education within the

undergraduate or graduate program of college.

3. Be a resident of Indiana and a citizen or permanent resident of the United States.
4. Demonstrate that his family has an adjusted income of less than fifteen thousand dollars (\$15,000) per year.

Is the Loan Renewable?

The student may renew his loan for four undergraduate years and for the period of graduate and professional study as long as his loan does not exceed five thousand dollars (\$5,000) in the case of an undergraduate or seventy-five hundred dollars (\$7,500) in the case of a graduate student.

Other Information About the Plan

1. Loans will be issued once during each academic year.
2. Checks for the loan amount will be issued in the student's name, directly to the college.
3. Checks will be issued no sooner than thirty (30) days prior to the first day of the semester or quarter for which the loan is made.

Important

No loan may be made for any purpose other than to cover costs directly connected with college. Therefore no loan may exceed the cost of the institution which the student will attend nor may it exceed that amount which remains after scholarships, loans and other aids have been subtracted from the cost of the college.

COLLEGE and the DRAFT!

- Q. Are student at Fort Wayne Bible College Deferred?
- A. Men are certified by the Dean of Students as full-time students. This certification goes to the local draft board which makes the final decision. Fort Wayne Bible College is an approved college and therefore students otherwise qualified for the 2-S deferment are granted this by their boards.
- Q. What if I am going to become a minister?
- A. The college will certify that Fort Wayne Bible College is an approved theological institution and that the student is preparing for the ministry. Such men usually receive the 4-D classification from their local board.
- Q. Do men interested in other phases of Christian service get 4-D classification?
- A. Yes, subject to the decision of the local board. Men may receive the 4-D classification in any of the Christian ministries programs if they affirm that they are preparing for full-time Christian service.
- Q. What about students in the non-degree program?
- A. If the church agency for which the student is preparing to work will certify that a degree is not necessary for such employment, those in the Standard Bible Program may also receive the 4-D classification.
- Q. Should young men choose the Christian ministries programs to avoid the draft?
- A. Such is an unworthy motive for selecting a college major or an occupation. Any young man who uses such as an escape from military service is hypocritical.
- Q. If I am not a theological student and I am only average, what are my chances of being drafted during the school year?
- A. National emergencies cannot be predicted, therefore no simple answer can be given. It has been our experience that even those in the lower half of their class are permitted to finish the year before being called up.
- Q. Should a young man enter service immediately or come to college and take his chances?
- A. Again, there is no simple answer. Some may prefer to get their military commitment out of the way and to take advantage of the Veterans' Educational Assistance Act. Others feel that the preparation they receive at Bible College will better prepare them to meet the temptations and challenges confronting them in military service, and to get a strongly Biblical and Christian philosophy of life to be of spiritual help to others.
- Q. If a young man has been delaying application because of uncertainty about the draft, is it now too late to get into Fort Wayne Bible College this fall?
- A. No. There is still room for men in the fall of 1966. The Governing Board has stated that all qualified students should be accepted as long as room is available. As soon as all application forms are complete the Admissions Committee will meet, make their decision and immediately notify the applicant.

YOUTH CONFERENCE —

"Heartfelt Thanks"

"Give my heartfelt thanks and also that of our young people," writes a pastor from Michigan, "for one of the best Youth Conferences I have ever attended. There must have been many hours of labor behind it."

Alumni who have been involved in previous Youth Conferences confessed, "This is the greatest ever". A youth leader brought some junior high youth for Saturday. "They loved the day and want to come back."

There were 458 registered and staying on campus. In all, 77 signed decision cards, but this in no way measures the results of such a Youth Conference. As one pastor said, "The Lord only knows what was accomplished for time and eternity in the lives of all who came".

A well-organized follow-up program now begins for each who signed decision cards. A home-study type of course has been given to each. They will receive personal letters from their counselors with lesson grading. They will have explained just what their decision means, and how they should continue in their new-found faith. Lessons point them to the Bible as life's guide; explain how to dispel doubts, resist temptation and receive forgiveness for sin; encourage them to live effectively and witness to others. Each has 28 Scripture memorization cards to begin hiding the Word in the heart.

Miss Joy Gerig, director of Christian service and advisor to the Youth Conference Committee states that she feels this is the most effective follow-up program she has seen.

Others who did not sign decision cards, but who made decisions at Youth Conference are invited to participate in the program.
